

INVITATION FOR BIDS

Sealed bids for the City Lake CAP Project (hereinafter "Project") will be received by the City of Union, 500 East Locust Street, Union, MO 63084, until 2:00pm, on May 31, 2017. The bids will be publicly opened and read aloud at 2:00pm, on May 31, 2017 at the City Hall, 500 East Locust Street, Union, MO 63084.

The Scope of Work includes removal of existing asphalt parking lots and walkways, construction of a two car parking lot along Clark Avenue and a five car parking lot at the Southeast corner of the lake; concrete sidewalks; construction of three low profile rock jetties, rock jetties to include a five foot wide concrete sidewalk; installation of a floating fishing dock; aeration system; construction of sediment basin on West side of Clark Avenue; reseeding and stabilization of disturbed areas, and other incidental items and work described in the Project Manual, or reasonably inferable therefrom.

A bid security in the amount of five percent (5%) of the bid amount must accompany each bid, in accordance with the Instructions to Bidders.

A prebid meeting will be held on May 25, 2017, at 2:00pm at City Hall.

The City of Union anticipates issuing notice to proceed in June of 2017.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this specification.

Effective January 1, 2009, and pursuant to RSMo 285.530 (1), No business entity or employer shall knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the state of Missouri. The successful bidder must submit a sworn affidavit and documentation affirming the business entity's enrollment and participation in the federal work authorization program and that all of its employees working for the contracted services are not illegal immigrants.

Upon signing the contract, the successful contractor and any subcontractor performing the work shall provide a ten-hour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees.

The City of Union hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
